Participants may use the Dive Center at boot Düsseldorf 2026 exclusively subject to the following conditions:

1. Prior to using the Dive Center, a comprehensive briefing by the responsible personnel of Messe Düsseldorf and/or the agency, their representatives, employees or other vicarious agents or other agents (hereinafter jointly referred to as "event personnel") is mandatory. Instructions of the event personnel must be followed at all times. They are authorised to issue instructions to the participants and, in particular, also authorised to exclude participants from using the Dive Center with immediate effect, without stating reasons.
2. **Participants are aware that they are taking part in a sporting activity that is associated with risks (danger to persons and/or property). The use of the Dive Center therefore requires extreme caution and is only permitted if the following conditions per programme are met:**

If you feel ill, you are excluded from diving. If you show any signs of a possibly contagious illness, protect yourself and others by not using the Dive Center. Should your health condition change while using the Dive Center you must contact the event personnel immediately.

3. Messe Düsseldorf GmbH shall not be liable in cases of simple negligence involving the breach of non-essential contractual obligations and, in cases of negligence, shall otherwise be limited to foreseeable damage typical for this type of contract. Essential contractual obligations are those without whose fulfilment the purpose of the contract is jeopardised and on whose observance the contractual partner may rely. However, the limitation of liability shall not apply in the event of injury to life, limb or health or in the event of breach of a guarantee or statutory strict liability.

4. **The participant and/or his/her legal representative(s) declare(s) with their signature that they accept the Terms and Conditions of Participation set out here and confirm that they have received and understood comprehensive instruction on the use of the Dive Center and that the conditions of participation set out in Section 2 have been met.** With their signature the participant(s) and/or their legal representative(s) expressly consent that Messe Düsseldorf GmbH collects their health data set out in the form, saves them and passes them on to authorised persons to the extent necessary for assessing the fitness and ensuring the safety of the event. The consent can be revoked at any time with effect for the future and without stating reasons (also see section 4 of these Terms and Conditions of Participation).

Information obligations pursuant to Art. 13 GDPR

1. Purpose of data collection and processing

Diving is an activity that naturally involves certain health risks. Existing medical conditions or health impairments can increase this risk. To protect participants, it is necessary to provide information about their state of health before use in order to assess their **fitness for diving** and identify health risks at an early stage. The information requested in section 2 of the form is collected and processed exclusively for this purpose.

3. Recipient of the data

For the purposes of running the event and ensuring safety, **event personnel** and, where applicable, **medically trained personnel** may access health information to the extent necessary to assess fitness for diving.

4. Legal basis for processing

Your health data are processed on the basis of your **express consent** pursuant to GDPR Art. 9 Sect. 2 a.

5. Duration of storage

Your details will be stored in accordance with the statutory limitation period.

6. Voluntary nature and revocation

The provision of health data is **voluntary**. However, use of the Dive Centre is only possible if the information provided has been checked by a doctor present at the Dive Center and fitness for diving has been confirmed. Consent can be **revoked at any time with effect for the future**. The revocation can be sent informally to Messe Düsseldorf GmbH (see above for contact details).

7. Data subject's rights

Pursuant to the GDPR you, in particular, have the right to:

- Information about the saved data (Art. 15 GDPR),
- Correction of wrong data (Art. 16 GDPR),
- Deletion (Art. 17 GDPR),
- Limitation of processing (Art. 18 GDPR),
- Objection (Art. 21 GDPR) and
- Data portability (Art. 20 GDPR).

In addition, you have the right to file a complaint with the competent data protection supervisory authority (State Commissioner for Data Protection and Freedom of Information North Rhine-Westphalia, Kavalleriestraße 2–4, 40213 Düsseldorf).
